In 2023 the Islesboro Community Center expanded afterschool care hours to meet the needs of working families and provide a safe, structured environment for elementary-aged children with snacks, art, music, and outdoor time. Dance instructors provided weekly classes in tumbling, acrobatics, ballet and hip-hop for Pre-K through 12 year olds. The students enjoyed an indoor play space, outdoor playground, and regular trail walks.

The Community Care program continued with holiday meals and weekly soup provided through the winter months to help address food insecurity. This was coupled with the Coats for Care exchange, which provides gently used winter clothing and accessories for residents for free.
