Youth & Development: In 2024, the Islesboro Community Center expanded afterschool care hours to meet the needs of working families and provide a safe, structured environment for elementary-aged children with snacks, art, music, and outdoor time. Dance instructors provided weekly classes in tumbling, acrobatics, ballet and hip-hop for Pre-K through 12 year olds. The students enjoyed an indoor play space, outdoor playground, and regular trail walks. Our afterschool programs, three days a week, offer seasonal arts and crafts, kitchen science, and music and movement for elementary students. Our partnership with Islesboro Island Trust gets students out on the trails for monthly hikes. Dance with Devan continues to be an incredible program - the spring recital Cinderella packed the hall.
